

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to limetreeroadsidepubcafe.com and Limetree Productions and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Limetree Productions include limetreeroadsidepubcafe.com. The Limetree Productions website is an art therapy website - prose, poetry, art, photography, music, songs, food and drink recipes site. By using the Limetree Productions website, limetreeroadsidepubcafe.com, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Limetree Productions may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

If you purchase Limetree Productions's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Sharing Information with Third Parties

Limetree Productions does not sell, rent or lease its customer lists to third parties.

Limetree Productions may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Limetree Productions, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Use of Cookies
